GENERAL RULES

1. This Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC). The *Handbook for Flower Shows*, 2017 Edition with revisions (July 2025) is the authority for all issues not covered by the Schedule which is the Law of the Show. *Handbook* references will be listed as “HB” throughout the schedule.
2. All classes are open to the public with the exception of Division I – Horticulture, Section N, Classes 66 – 68.
3. All entries are to be the work of one (1) exhibitor except where noted in the schedule.
4. Each exhibitor is limited to one (1) entry per class, except in the Horticulture Division. An Exhibitor may make more than one entry per class if each is a different species, variety, cultivar, type or color.
5. Entry cards may be obtained at West Trenton Garden Club (WTGC) meetings, from Consultants, Flower Show Chairmen, Club President, and at registration. All exhibitors are responsible for completing their own entry cards unless noted differently in the schedule. All cards should be completed with a #2 pencil or waterproof ink, in advance, if possible. Address labels are encouraged. Entry cards will be reviewed by Classification Committee and entry numbers will be assigned by Entries Committee.
6. All entries (except photography) and those brought in by the judges will be received on Thursday, September 17, 2026, from NOON to 6 PM at the show’s location. Judges’ entries will be received on Friday, September 18, 2026, from 9AM to 10AM. Photography entries will be accepted on Monday, August 3, 2026, and Monday, September 14, 2026, at the general monthly meeting or delivered to the Photography Chairperson no later than September 10, 2026.
7. There must be an emphasis on FRESH plant material. No artificial plant material is permitted in any exhibit in any division.
8. The Classification Chairmen for each division will check exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges’ responsibility.
9. All exhibitors must be off the show floor by 10:00 AM on September 18, 2026, prior to judging.
10. The General Chairman and the Classification Chairmen for each division are available during judging for possible consultations. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.
11. Judging will commence at 10:30 AM on Friday, September 18, 2026. Photography will be judged on Thursday, September 17, 2026, at 6:30 PM. Judging is based on the NGC’s Standard System of Awarding as stated in the HB, Chapter 5.
12. The decisions of the judges are final. Awards may be withheld if not merited.
13. The show will open to the public on Friday, September 18, 2026, at the completion of judging and the show will close at 5 PM. The show will re-open at 10AM on Saturday, September 19, 2026, and close at 4 PM.
14. All entries/properties must be removed by exhibitor (or a representative) on Saturday, September 19, 2026, after the show closes at 4PM. All dismantling must be completed by 6PM. Any remaining exhibits will be discarded.
15. The exhibitors must keep their exhibits in good condition for the duration of the show.
16. Containers, bases, and accessories must be marked with the exhibitor’s name in a hidden area.
17. The WTGC will strive to assure the safety of all items after arrival and placement but is not responsible for any loss or damage to exhibits.
18. All tables will be topped and skirted with neutral fabric unless noted differently in the schedule.
19. All exhibits will be staged for the best viewing advantage.
20. Plant material on the *NJ Conservation Guide List* is not permitted unless grown by exhibitor or legally acquired and must be so stated on a 3” x 5” card with exhibit. Conservation Guide List posted on the Garden Club of New Jersey (GCNJ) website at: <https://gardenclubofnewjersey.com/flower-shows/>.
21. Plant material on the *Category I Invasive Plant List of the Nature Conservancy* is not permitted except in Educational Exhibits in the Education Division. List posted on the GCNJ website. List posted on the GCNJ website at: <https://gardenclubofnewjersey.com/flower-shows/>.

National Garden Clubs, Inc.

Standard Flower Show Awards

Standard System of Awarding

The National Garden Clubs Inc. (NGC) Standard System of Awarding is used in all divisions as follows:

- a. Only one (1) first place (blue) ribbon per class or subclass, must score 90 points or more.
- b. Only one (1) second place (red) ribbon per class or subclass, must score 85 points or more.
- c. Only one (1) third place (yellow) ribbon per class or subclass must score 80 points or more.
- d. One (1) or more Honorable Mention (white) ribbons as merited; must score 75 points or more.

We kindly request that all 90+ scoring, non-blue ribbon winning exhibit entry cards, be marked with a "90+" indication and signed by an Accredited NGC, Inc. Flower Show Judge on the panel.

Top Exhibitor Awards

Horticulture Division Awards

Award of Horticultural Excellence (HB, p. 40)

Division Award [A rosette of green, orange and blue ribbons] May be awarded to the highest scoring, correctly named blue ribbon exhibit (95 or above) in the entire Horticulture Division entered by a single exhibitor provided all General and Horticulture requirements are met. One award offered, in Division I, Horticulture, Sections A-N (Classes 1-68).

Arboreal Award (HB, p. 40)

Section Award [A rosette of green ribbons in two shades] May be awarded to the highest scoring, correctly named, blue ribbon exhibits (95 or above) in the noted sections provided all General and Horticulture requirements are met. Two awards offered, one award per section in Division I, Horticulture, Sections L and M (Classes 57-65).

Award of Merit (HB, p. 41)

Section Award [A rosette of orange ribbons] May be awarded to the highest scoring, correctly named, blue ribbon exhibits (95 or above) in the noted sections provided all General and Horticulture requirements are met. Classes in each eligible section must be a cut specimen and share some common characteristics. Seven awards offered, one award per section in Division I, Horticulture, Sections E-K (Classes 21-56).

Grower's Choice Award (HB, p. 41)

Section Award [A rosette of dark green ribbons] May be awarded to the highest scoring, correctly named, blue ribbon exhibits (95 or above) in the noted sections provided all General and Horticulture requirements are met. Four awards offered, one award per section in Division I, Horticulture, Sections A-D (Classes 1-20).

Design Division Awards

Award of Design Excellence (HB, p. 42)

Division Award [A rosette of gold ribbons] May be awarded to the highest scoring blue-ribbon exhibit (95 or above) in the entire Design Division entered by a single exhibitor provided all General and Design requirements are met. One award offered in Division II, Design, Sections A-C (Classes 1-8).

Petite Award (HB, p. 43)

Section Award [A small rosette of blue and white ribbons] May be awarded to the highest scoring blue-ribbon exhibit (95 or above) in the section noted provided all General and Design requirements are met. One award offered in Division II, Design, Section A (Classes 1-3).

Table Artistry Award (HB, p. 43)

Section Award [A rosette of burgundy ribbons] May be awarded to the highest scoring blue-ribbon exhibit (95 or above) in the section noted provided all General and Design requirements are met. One award offered in Division II, Design, Section C (Classes 6-8).

Education Division Award

Educational Top Exhibitor Award (HB, p. 43)

Section Award [A rosette of brown and white ribbons] May be awarded to the highest scoring exhibit (95 or above). A minimum of two (2) educational exhibits designated as eligible must be present. One award offered in Division III, Education, Section A, Exhibits 1 and 2.

Youth Division Award

Youth Top Exhibitor Award (HB, p. 44)

Section Award [A rosette of red, white and blue ribbons] May be awarded to the highest scoring exhibit (90 or above) in the Youth Section. No minimum number of exhibits required. Judged using Adult Scale of Points. Six awards offered, one per age group, **Ages 5-8, Ages 9-13 & Ages 14-8, in Division IV, Section A, Classes 1-2.**

Botanical Arts Division Awards

Botanical Arts Artistic Crafts Award (HB, p. 44)

Section Award [A rosette of navy ribbons with gold lettering] May be awarded to the highest scoring exhibit (95 or above) in the Botanical Arts Division, Artistic Crafts Section. One award offered in Division III, Botanical Arts, Section A, Classes 1-3.

Botanical Arts Photography Award (HB, p. 45)

Section Award [A rosette of black and white ribbons] This award is offered to the highest scoring exhibit (95 or above) in the Botanical Arts Division, Photography Section. One award offered in Division III, Botanical Arts, Section B, Classes 4-7.

Additional NGC Awards

Award of Appreciation (HB, p. 45)

[A rosette of orchid ribbons] A non-competitive award which will be presented, if merited, by the Flower Show Committee to the exhibits in the sections noted. Three awards offered: two in Division III, Education, Section B, Exhibits 3 and 4; and one in Division IV, Youth and Sponsored Groups, Section B, Class 3.

Special Award (HB, p. 46)

[A rosette of yellow ribbons] A non-competitive award which may be presented by the Flower Show Chairman or Committee to recognize individuals for outstanding Flower Show contributions.

Sweepstakes Award (HB, p. 46)

[A rosette of green and white ribbons] Determined by the Flower Show Committee. Awarded to two exhibitors with the highest total of award points, one award in the Horticulture Division and one award in the Design Division. Award points are calculated as follows: Top Exhibitor Award = 7 points; First Place = 5 points; Second Place = 3 points, and Third Place = 1 point. Honorable Mention has no value. In case of a tie, the exhibitor with the most exhibits wins.

Horticulture Division Awards

Gardening Friends Award

Section Award [A rosette of green and yellow] This special award will be presented in fond memory of all West Trenton Garden Club members deceased and their love of gardening. May be awarded to a high scoring, correctly named, blue ribbon exhibit in the noted section provided all General and Horticulture requirements have been met. This award is to be presented by the **Flower Show Committee**. One award offered, in Division I, Horticulture, Section N (Classes 66-68).

Millija Lovett Horticultural Award

Division Award [A silver engraved tray and a rosette of blue and silver ribbons] May be awarded to a correctly named, highest scoring blue ribbon exhibit in any class/section of the Horticulture Division. This award is to be presented by the **Horticulture judges**. One award offered, in Division I, Horticulture, Sections A-N (Classes 1-68).

Design Division Award

The Mari Epley Award

Division Award [A rosette of pink and green ribbons] May be presented to a blue-ribbon exhibit in the Design Division which has best demonstrated basic design elements to obtain beauty, harmony, distinction and expression. This award is to be presented by the **Flower Show Committee**. One award offered in Division II, Design, Sections A-C (Classes 1-8).

Additional WTGC Awards

The Audrey Harker Educational Award

Division Award [A rosette of brown/white ribbons] May be awarded to an Educational Exhibit designed to instruct the public in some phase of the National Garden Clubs, Garden Club of New Jersey, or West Trenton Garden Club objectives. This award is to be presented by the **Flower Show Committee**. One award offered in Division IV, Education, Sections A-B, Exhibits 1-4.

West Trenton Garden Club (WTGC) Special Award

Section Award [A rosette of yellow/white ribbons] May be awarded to an exhibit scoring 90 points or more in Division V. These awards will be determined and placed by the **Flower Show Committee**. Two awards offered in Division V, Botanical Arts, Section A (Classes 1-3); and Section B, Classes 4-7.

DIVISION I. HORTICULTURE

“The Glory of Autumn”

All classes in this Division are eligible for the *Award of Horticultural Excellence* and the *WTGC Millija Lovett Horticultural Award*.

HORTICULTURE RULES

1. Refer to General Rules for entry receiving procedures and other information.
2. The NGC Horticulture Exhibit Policies are printed in the HB, Chapter 6 (p. 55), under “Exhibiting in the Horticulture Division.”
3. The rules for a single species cut or container-grown specimen are listed in the HB or its supplement, *Horticulture Exhibiting and Judging*.
4. All plant materials must be fresh and have been grown by the exhibitor.
5. Container-grown plants must be in the possession of the exhibitor for at least 90 days prior to the show. Multiple plantings must be grown together for six (6) weeks prior to the show. Cut specimens of annuals, biennials and perennials must have been in the exhibitor’s possession from seeds, cuttings, or immature plants and grown to maturity. Bulbous blooms must have been in exhibitor’s possession from planting of bulb, tuber, corm, rhizome, etc., at least 90 days or it must have been cared for as a mature plant. Arboreal specimens must be in the exhibitor’s possession for at least six (6) months.
6. Container diameter is determined by measuring the maximum interior diameter. See Schedule for maximum diameter of containers. Double potting is permitted if interior container does not show.
7. All entries are to be labeled by genus, specific epithet and/or variety – or patented/trade-marked names. Common names may also be given. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify her/his entry by its binomial name or currently acceptable scientific designation. Example: Genus species ‘Cultivar/Variety’ (Common Name)
8. Entry cards are to be filled in advance if possible. Refer to HB, Chapter 6, p. 57 for an example of a correctly filled out entry card and page 8 of this document.
9. Containers for cut specimens and wedging (plastic or bubble wrap) will be provided by the Flower Show Committee. Cut specimens should not have foliage below the water line.
10. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower but should be exhibited as a foliage plant if they are grown for their leaves.
11. Hanging plants will not be hung. Instead, they will be raised by Committee on an inverted container provided by exhibitor if possible.
12. Specimens with a class designation in the schedule may not be entered in the ‘Any Other Worthy’ class.
13. The Horticulture Classification Committee Chairman and/or General Show Chairman are free to subdivide classes by color, form, size, cultivar, variety or other distinguishing characteristics.
14. Plant entries should consist of a single specimen unless noted differently in Class description.
15. Arboreal needled evergreen entries in Section M require proper conditioning and will be exhibited without water, tied to a lattice board by Committee.
16. Fresh plant material may not be wired or treated in any manner. Staking of plants is permitted if unobtrusive and if stakes do not exceed height of plant.

- 17. Pre-registration by September 1, 2026, is required for Section A.
- 18. **Due to space limitations, only plants listed in schedule may be exhibited.**
- 19. The Scales of Points for Horticulture can be found in HB, Chapter 14, p. 129-130.

All entry cards must be filled out both top and bottom. Exhibitors will receive an entry number* to be used for Horticulture. Printed labels are acceptable (and preferred) for the name/address area on the top and bottom of the entry card. Botanical names are required. The names should be **underlined** if hand printed.

Additional Requirements:

Division I, Section A – Combination Plantings: A diagram listing binomial or currently accepted scientific identification is required on a 4" x 6" index card.



HORTICULTURE SECTIONS AND CLASSES

SECTION A. "Fall Friends"

Combination Plantings

Eligible for Grower's Choice Award

A grouping of three or more botanically different plants. **Naturalistic** accessories are permitted in all combination plantings. **A diagram listing binomial or currently accepted scientific identification is required on a 4" x 6" card.** Container not to exceed 12" in any direction. Staging by Committee. Pre-registration required for all classes with Horticulture Chairman. HB, p. 59.

Class 1 - A Dish Garden of Cacti and/or Succulents

A miniature landscape in an open low-volume shallow container provided by exhibitor.

Class 2 - A Planter of Foliage, Herbs and/or Flowering Plants

A grouping of plants in an indoor or outdoor container provided by exhibitor.

Class 3 - A Terrarium

(maximum 6 entries)

A miniature landscape in a container with high transparent sides provided by exhibitor.

SECTION B. "Colors of the Season"

Container-Grown or Mounted Flowering/Fruited Plants

Eligible for Grower's Choice Award

Container-grown or mounted flowering/fruited plant in container measuring 10 inches in maximum diameter or mounting not to exceed 14" in maximum diameter. Single or self-multiplying plant of same cultivar and color, must be in **bloom or bearing fruit.** HB, p. 58.

Class 4 - *Anthurium andraeanum*

Class 5 - Orchids -- One plant per container

Class 6 - *Streptocarpus sect. Saintpaulia* (African Violet)

Class 7 - Any other container-grown or mounted flowering/fruited plant

SECTION C. "Foliage Folic"

Container-Grown or Mounted Foliage Plants

Eligible for Grower's Choice Award

Single plant or self-multiplying plants of same cultivar and color, container or mountings not to exceed 14" in diameter. Pre-registration required with Horticulture Chairman for any hanging plant.

Class 8 - *Dracaena*

Class 9 - *Epipremnum aureum* (Pothos)

Class 10 - *Polypodiopsida* (Ferns)

Class 11 - *Hedera helix* (Ivy)

Class 12 - *Philodendron*

Class 13 - *Sansevieria*

Class 14 - *Schefflera*

Class 15 - Any other container-grown or mounted foliage plant

15a. Container 6" or under in diameter

15b. Container over 6" to 14" in diameter

SECTION D. "Say Aloe to My Scarecrow"

Cacti and/or Other Succulents

Eligible for Grower's Choice Award

Container-grown single or self-multiple planting or multiple plants of same cultivar and color. Container size not to exceed 12" in any direction.

Class 16 - *Aloe*

Class 17 - *Crassula ovata* (Jade plant)

Class 18 - *Echeveria*

Class 19 - *Haworthia*

Class 20 - Any other cactus or succulent

SECTION E. "Bountiful Harvest"

Edible Fruits and Vegetables

Eligible for Award of Merit

Stems required unless otherwise specified. Staged by Committee, on eco-friendly plates. Larger specimens will be placed directly on covered table. One specimen unless noted otherwise.

Class 21 - *Capsicum* (Pepper), any type

21a. 2" in diameter or larger, 3 specimens of the same variety

21b. Under 2" in diameter, 5 specimens of same variety

Class 22 - *Cucurbita* (Squash)

22a. Summer squash

22b. Winter squash

Class 23 - *Solanum lycopersicum* (Tomato)

23a. 3" in diameter or larger, 3 specimens, no stems, exhibited stem side down

23b. Under 3" in diameter, 5 specimens of same variety, no stems

23c. Grape or Cherry Tomatoes, 7 specimens of same variety, no stems

Class 24 - Any other edible fruit or vegetable specimen

24a. Large specimens - Over 6" in diameter, 1 specimen

24b. Medium specimens - 2-6" in diameter, 3 specimens

24c. Small specimens - Under 2" in diameter, 7 specimens

SECTION F. "Time to Dry Those Herbs"

Herbs

Eligible for Award of Merit

Cut specimens, 1 stem, 6" to 20" in length. Specimens must be exhibited at their peak of usefulness. Staged in clear tubes or containers provided by Committee.

Class 25 - *Lavandula* (Lavender)

Class 26 - *Mentha* (Mint)

Class 27 - *Origanum*

27a. *O. majorana* (Sweet Marjoram)

27b. *O. vulgare* (Oregano)

Class 28 - *Rosmarinus officinalis* (Rosemary)

Class 29 - *Salvia officinalis* (Sage)

Class 30 - *Thymus* (Thyme)

Class 31 - Any other herb

SECTION G. “Autumn Beauties”

Flowering Herbaceous Perennials

Eligible for Award of Merit

Single cut stem with attached foliage unless otherwise noted, 4” to 18” in length. Staged in clear tubes or containers provided by Committee.

Class 32 - *Aster* - 1 spray of 5 open flowers

Class 33 - *Coreopsis*

Class 34 - *Salvia yangii* (Russian Sage)

DESIGN RULES

1. Refer to General Rules for entry receiving procedures and other information.
2. Designs must be the work of one (1) individual.
3. Designer is on her/his honor that the design being entered has not been previously entered or previously judged in an NGC Flower Show.
4. **If a designer is unable to fulfill his/her assignment, it is the designer's responsibility to find a replacement.**
5. The NGC Exhibit Policies are printed in the HB, Chapter 7, p. 79, Exhibiting in the Design Division, under NGC Policies and Guidelines.
6. Plant material must be used in every exhibit and need not have been grown by the exhibitor. This includes fresh and/or dried material. Fresh plant material may not be treated in any manner. Dried plant material may be treated.
7. Plant material and non-plant material permitted and not permitted in the Design Division are printed in HB, Chapter 7.
8. Landscapes or scenes are not permitted in the Design Division. American and other national flags may not be incorporated into designs or used as underlays, swags, or the like. For additional information on “Exhibiting in the Design Division.” See pp, Chapter 7, pp. 79-81.
9. The Designer has the freedom to choose Traditional or Creative Style with any Design listed unless restricted by the schedule.
10. Designers are free to use special staging properties, e.g., staging panels, frames, hanging devices, etc., unless disallowed in the schedule or provided by the Flower Show Committee. Special staging must comply with the size requirements and restrictions stated in the schedule. Exhibitors may enter multiple classes within the Design Division, but only one (1) exhibit per class.
11. Advance registration with the Design Entries Chairman/Consultant is required by **August 17, 2026.**
12. All plant material used in the design must be identified on a 3”x5” card provided by the exhibitor and included with the entry card. Common names are acceptable. Botanical names are optional and may be included.
13. The exhibitor is required to conform to the stated description and limitations of the Design Type if named in the class. **The exhibitor is responsible for keeping his/her design(s) in good condition throughout the duration of the show.**
14. Rules for Design Types, Table Designs, Advanced Design Types and Table Appointments can be found in HB, Chapter 7.
15. Consultants are to review designs in their individual sections for conformance to the schedule.
16. The Scale of Points for Design is listed in HB, Chapter 14, p. 130.

Class 1 “Back to School” (4 entries)

A Design (freedom of style) – No larger than 6” in height, 6” in width, and 6” in depth. Staging panel and underlay provided by Committee (6”W x 6”D x 6”H), may be covered by designer. Staged on an 18”H shelf atop a 29” off-white covered table. Designer’s choice of plant material and other components. Viewed from the front. HB, p. 73.

Class 2 “Fall Festival” (4 entries)

The start of fall festivals brings cooler brisk days filled with the colors of the season.

A Design in the Manner of a Traditional Mass – Not to exceed 8” in height, 8” in width, and 8” in depth. Staging panel and underlay provided by Committee (8”W x 8”D x 8”H), may be covered by designer. Staged on a 10” black cube, placed on a table 29” from the floor against a neutral-colored curtain wall. Designer’s choice of plant material and other components. Viewed from the front. HB, p. 73.

Class 3 “Harvest Moon” (4 entries)

This orange-red moon that occurs every September represents abundance, transformation, and a transition period.

A Design (freedom of style) – Not to exceed 12” in height, 12” in width, and 12” in depth. Staging panel and underlay provided by Committee (12”W x 12”D x 12”H), may be covered by designer. Staged on a 12” black cube, placed on a table 29” from the floor against an 8’H neutral-colored curtain wall. Designer’s choice of plant material and other components. Viewed from the front. HB, p. 73.

SECTION B. “Sweater Weather”

Class 4 “Woodsy” (4 entries)

The beauty of nature is calling! Take a walk in the woods for inspiration.

A Creative Design – Staged on a table 29” from the floor, against a neutral wall. Space allotted 30”W x 30”D. Designer’s choice of plant material and other components. Staging panel and underlay provided by the exhibitor required. Viewed from the front. HB, pp. 71-72.

Class 5 “The Pumpkin Patch” (4 entries)

Pick your favorite color – we are not just pumpkins but stunning autumn gourds.

A Design (freedom of style and type) – using fresh and/or dried materials incorporating a pumpkin(s) and/or other gourd(s). If using a pumpkin/gourd as the container, it should be sealed to limit rotting. Design to be staged on a table 29” from the floor, against a neutral-colored wall. Space allotted 30”W x 30”D. Staging panel and underlay provided by the exhibitor required. Viewed from the front.

SECTION C. “Special Gatherings for the Third Season of the Year”

Class 6 “Grateful Hearts Gather Here”

A Functional Table Set for Two (Semi-formal) – Staged on a 36” square table, 30” from the floor **staged in front of a neutral-colored curtained wall.** A decorative unit suitable for the allotted space and a table covering with a 12” minimum overhang are required. Designer’s choice of plant material and other components. Placemats or underlay permitted. Viewed from the front. HB, p. 76.

Class 7 “Teatime in the Apple Orchard”

(4 entries)

What better way to spend a fall day, picking apples and enjoying cinnamon spiced tea!

A Functional Tray for One (Informal) – Exhibitor to provide tray not to exceed 19”W x 16”D or 18” round. Staged on a quarter of a 60” round table 29” from floor. A decorative unit is required. Designer’s choice of plant material and other components. Viewed from the front. HB, p. 76.

Class 8 “Oktoberfest”

(4 entries)

A German tradition that is celebrated worldwide. Friends will surely join in the fun. Prost!

A Functional Table for One (Informal) – Staged on a 30” round high-top cocktail table, 42” from the floor, in front of a neutral-colored wall. With a decorative unit suitable for the space allotted. Designer’s choice of plant material and other components. Exhibitor to provide a table covering with a 12” minimum overhang. Viewed from the front. HB, p. 76-77.

EDUCATION RULES

1. Refer to General Rules for entry receiving procedures and other information.
2. Advanced registration with the Education Entries Chairman is required for competitive educational exhibits by **August 10, 2026, and September 1, 2026**, for non-competitive exhibits.
3. Non-competitive educational exhibits are by invitation only from the Flower Show Committee.
4. Educational exhibits may be the work of more than one individual or organization unless a Student Judge or an Accredited Judge is seeking exhibiting credit for preparing an educational exhibit.
5. An exhibit must occupy a minimum of eighteen (18) square feet surface area.
6. Each exhibit will be staged against a neutral wall on a table measuring 8’L x 30”D x 29”H provided by Committee.
7. Some plant material is encouraged but not required.
8. Entry cards are to be completed by exhibitor(s) as indicated in General Rules.
9. Consult HB, Chapter 8, for further information on entering the Education Division of a Flower Show.
10. The Scale of Points for Educational Exhibits can be found in HB, Chapter 14, p. 130.

Exhibit 1 “Winter Sowing? What it is All About?”

Winter sowing is a seed-starting technique where seeds of certain vegetables, flowers, and herbs are started outdoors in containers in late autumn or winter. Gardeners favor this method for starting seeds because it is easy, does not take up indoor space, and is a low-cost way to produce a lot of seedlings. Come and learn from an expert when to winter sow and get step-by-step instructions for sowing seeds in recyclable containers.

Exhibit 2 “Where History and Beauty Meet”

At the intersection of West Upper Ferry and Bear Tavern Roads in Ewing Township, NJ you will find a special corner of beauty and history: Birmingham Mini-Park. It is the very spot where General George Washington and his troops split their forces during the daring march to Trenton in 1776. Once a vacant lot, the park has been transformed into a shaded, flower-filled space where residents stop to rest, read, or simply enjoy the blooms. Visitors come by foot, bike, or car to pause and take in the view. A group of dedicated volunteers maintain the park. In 2025, the Garden Club of New Jersey, Inc. awarded WTGC the “*Hazel Bowen Sternat Civic Beautification Trophy*” for the Birmingham Mini-Park beautification.

Exhibit 4 “Head, Heart, Hands & Health”

A display of the many activities provided by the Rutgers’s New Jersey Agricultural Experiment Station -- Cooperative Extension of Mercer County. BOTANICAL ARTS RULES

Artistic Crafts

1. Refer to General Rules for entry receiving procedures and other information.
2. Exhibit must contain some fresh and/or dried plant material. Only dried material may be treated.
3. No artificial plant, endangered, or locally invasive plant material may be used.
4. Incorporation of wire, glues, paint and paint finishes are permitted in Artistic Crafts.
5. **All entries must include a 4” x 6” card listing plant material used in the artistic craft entry.**
6. The rules for Artistic Crafts are printed in HB, Chapter 10, pp. 94-95.
7. Artistic Crafts Consultant to review entries for conformance to the schedule.
8. The Scale of Points for judging Artistic Crafts is listed in HB, Chapter 14, p. 131.

Photography

1. Refer to General Rules for entry receiving procedures and other information.
2. The Classes are open to all photographers, regardless of skill level.
3. The rules for Photography are printed in HB, Chapter 10, pp. 95-96.
4. Photography entries must pre-register with Photography Consultant by September 10, 2026.
5. Entries can be shot with a digital or film-based camera. Photos may be enhanced using in-camera and post-production techniques such as cropping, filters, and darkroom manipulation.
6. Use of advanced techniques to obtain a more abstract/creative image is acceptable.
7. Due to space limitations, each exhibitor may enter any class, but only one entry per class.
8. Each class is limited to ten (10) entries. If 10 are not pre-registered for each Class before the show, additional photographs will be accepted up to the 10 limit per Class at time of registration.
9. All photographs **must be matted in white** with a maximum size of 11” x 14” including the mat. No frames, wire, or glass. Hanging mechanisms will be supplied by Committee.
10. Exhibitors are encouraged to label photographed plant material, if possible, preferably with current scientific designation.
11. All photographs must be labeled on the back with exhibitor name, address, phone, and email.
12. Entry cards are to be completed by exhibitor in advance if possible. At registration, Photography Consultant will review entries for conformance to schedule. Each exhibitor will receive an Entry Number from the Entry Chair to complete registration. Committee reserves the right to determine if a photo does not fit into a particular category.
13. Staging at the discretion of Committee including the right to subdivide entries, if required.
14. The Scale of Points for judging Photography can be found in HB, Chapter 14, p. 131.

ARTISTIC CRAFTS SECTION AND CLASSES

SECTION A. “Old Hallows Eve” (Competitive)
